- i) The applicant must be a permanent resident of West Bengal.
- ii) The applicant must have knowledge of local languages (should be able to read, write and speak in Bengali).
- iii) Age relaxation will be given for the reserved candidates as per existing norms of the State Government.
- iv) Only online Applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled. If the online application details submitted by the applicant differ with the original testimonials, that application shall be liable to be cancelled.
- v) If proper signature and photograph are not uploaded at the time of online application that application shall also be liable to be cancelled.
