#### Nature of work/responsibilities and expectations:

The Clinical Trial Coordinator is expected to report as & when a mechanical thrombectomy procedure is decided for a patient round the clock by the Jipmer stroke team and the radiodiagnosis department initiates the proceedings. He/She will record the informed consent and will clerk in the detailed proforma of the recruited patient and including the neuro-imaging characteristics and dispatch them online to the sponser in a timely manner. She/He will also maintain the clinical trial- related hard and soft copy documents including the regulatory, financial and scientific documents pertaining to the trial. He/She will also followup and record details of the patient till the study end and document and dispatch the same to the sponser in a timely manner. He/She will also laise with the investigators, sponser and the research division concerned with the research data, finanacial matters and regulatory works related to the Grassroot trial.

#### Eligibility criteria (Qualifications and experience)

**A. Essential:**

Diploma/Degree in clinical trials or Pharm D/ M Pharm or MD Pharmacology or MSc Nursing

**B. Desirable:**

Previous experience in clinical trials for a minimum of 1 year period after the above qualification.

Applicants will be shortlisted based on the details furnished in the application, CV, and the documentary proof provided. The list of eligible candidates will also be displayed on the JIPMER website. The final selection will be based on CV, application, and written test/interview.

### EVALUATION CRITERIA:

After the evaluation of the application form, the recruitment process will be as follows:

#### a. Written test

1. Non communicable disorders (Hypertension, Diabetes, Hyperlipidemia, Heart Disease etc)
2. Stroke – Definition, types and subtypes, Symptoms and signs, risk factors, Treatment modalities, prevention, investigations such as CT/MRI and angiogram, Thrombolysis and intervention.
3. Stroke complications and sequelae and disability scales
4. Drugs used in the treatment of stroke.

#### b. Interview (areas which will be covered)

General knowledge and practical use of computers and data handling, aptitude and commitment to work and ability to work in a group and get along with colleagues, motivation for research activities.

### TERMS AND CONDITIONS:

1. This position is purely on contract basis for an externally sponsored project, and the person engaged will have no claim to any regular post in JIPMER at any time. Further, the position is only for the duration of the project and based purely on external funding support for the project.
2. The engagement may be extended or curtailed at discretion of the Project Investigator.
3. Qualification and experience should be in a relevant discipline/field and in a reputed institution/organization. The experience should have been gained *after acquiring the essential qualification*.
4. Qualification, experience, other terms, and conditions may be relaxed/ altered at the discretion of the Principal Investigator.
5. Valid email ID and mobile number are compulsory.

Interviews for the post may be conducted in person or via videoconferencing, at the discretion of the Principal Investigator. In the latter case, it will be the individual candidate's responsibility to ensure access to a suitable device (computer/ laptop/ mobile) with audio and camera facilities, and an adequate internet connection.
