3. **Last date of receipt of application as per format given in our website**. Application as per requisite format along with self-attested photocopies of testimonials in support of Educational Qualifications and work Experience will be submitted to OIC, ECHS Cell,(Stn HQ) Misa Camp by **20 Jan 2026** in duplicate. Any application received after 1000 (hrs) **20 Jan 2026** will not be accepted.

4. **Interview Date, Timing & venue**. Candidate must reach Stn HQs (ECHS Cell), Misa Camp at 0900 hrs on **28 Jan 2026** for the interview to be held between 1000 (hrs) to 1400(hrs). Candidates must bring all the original certificates, work experience cert, discharge book PPO, service records and 02 PP size colour photographs at the time of interview. No TA/ DA is admissible. Only candidates meeting the Qualitative requirements may apply. Only shortlisted candidates will be called for the interview. An IT aptitude test, based on likely IT related tasks at Polyclinic, will be conducted for OIC Polyclinic post
